A maximum aggregate of the lesser of (i) 10% of ACV or (ii) \$150,000 (or equivalent in local currency) will be paid for Referral Incentive and Influence Incentive on one opportunity.

Referred opportunity must be registered via CyberArk's defined process and approved by CyberArk prior to deal closure.

For Partners who engage to provide opportunity support to CyberArk the Partner must provide evidence of meeting the relevant Influence Criteria.

CyberArk reserves the right to adjust Partner benefit in opportunities whereby additional customer discounts are approved to win the business or where multiple partners are engaged in the opportunity.

- CyberArk will not pay, nor should a CyberArk employee promise to pay, to any third party a Referral or Influence Fee unless the third party is a Partner and has fulfilled the requirements as defined by the CyberArk Partner Program and as set out in these terms and conditions for the applicable opportunity.
